SECTION 3 HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW -Black opaque thin viscosity liquid with aromatic odor. Warning! Flammable liquid and vapor. Keep away from heat sparks and flames. May cause eye, skin and respiratory tract irritation. If swallowed do not induce vomiting. Get immediate medical attention.

POTENTIAL HEALTH EFFECTS

Eyes: Liquid is moderately irritating to the eyes.

Extinguishing Media -

Use water fog, foam, dry chemical or CO2. Use water spray to cool fire-exposed containers and to protect personnel.
